

Philanthropy Network COVID-19 Event Policy

Philanthropy Network is looking forward to returning to in-person events but recognizes the risks involved. The safety of all attendees is a shared responsibility of Philanthropy Network, our partners, and each attendee. Philanthropy Network is doing its part by monitoring and complying with local, state, and federal guidelines to the extent applicable and implementing our own safety protocols. Each attendee must also do their part by adhering to applicable regulations and all health and safety guidelines, policies, and protocols implemented by Philanthropy Network.

Watch out for Symptoms

According to the United States Center for Disease Control and Prevention (CDC), people sick with COVID-19 report experiencing a wide range of mild to severe symptoms. Below are some of the most common reported symptoms. Philanthropy Network stresses that if you are experiencing any of these symptoms or have been exposed to anyone experiencing these symptoms, you must: 1) stay home, self-isolate, and do not attend the event; and 2) contact a healthcare professional for treatment.

- Follow-up with all attendees if attendees report becoming ill during or immediately following the conference.

Attendee Code of Conduct:

Philanthropy Network seeks to promote healthy behaviors and maintain a healthy environment to reduce the risk of spreading COVID-19 while at the event. We appreciate your cooperation in ensuring a safe and healthy environment for you, fellow attendees, and others. Masks are not mandatory, but we encourage the use of masks during the event.

To attend the event, please adhere to the following:

- I agree that entry into the event is conditional upon having received the COVID vaccine and booster or having received a negative COVID-19 test at least 36 hours before the event start date.
- I agree not to attend if I, a member of my household or a guest traveling with me feels sick.
- I will not attend if I, a member of my household or a guest traveling with me tests positive for COVID-19 or has been exposed to someone with symptoms or someone with suspected /confirmed COVID-19.
- I agree to wash my hands regularly with soap and water and to use hand sanitation stations.
