Community-led Philanthropy during Crisis: How Giving Circles of Color Can Transform Traditional Philanthropy

Panel discussion with local leaders about how giving circles of color have responded to the current crises and how their giving circle models can intersect with traditional philanthropy. How does community-led philanthropy share power, shift power, and build power, and what does this mean for communities of color?
